In our respective departments we got the approved status. Along with which we got allied privileges, like protection for principal office bearers, full time permission, Special casual leave etc. we also got Liaison officer permission to monitor the DPC and Panels etc. to ensure fair play.

It was our focus on the issue of reservation and its impact on the seniority of our members which brought into notice the issue of flaw in the preparation of Seniority Lists, in respect of direct recruits, being followed in our departments. The procedure being followed was that roster point based appointment orders were being adopted as order of Seniority. The issue was successfully represented to the Department and we got the things set right. This was one of the biggest achievements of our Association. We are fortunate that the Management was fair and considerate enough to concede to our demand, and we got the issue resolved without any process involving the Court of Law. We are grateful to the Management also for their cooperation.

During the one decade we could establish our Association Offices at RTPP and DrNTTP (VTPS), Ibrahimpatnam, Vijayawada. Our Association's dream is to have a Building of its own, with facilities, like Association Office, Meeting Hall, Guest Rooms etc. at a centrally located place.

It is very happy to note that our Association Members are becoming Life Member also. The life Membership fee is helping us to form a Corpus Fund for sustenance of the Association activities.

Let us pledge that we all the members shall strengthen the hands of the management and put our best efforts to achieve the Organizational objectives and goals, leading it to greater heights at National level in all aspects.

It is learnt that your Association has completed ten years of its formation and on that occasion taking out a Souvenir, it is a good and appreciable practice.

The Reservation issue is day by day growing into a chronic problem for the Nation. The special privilege available in the Reservation System is attracting different sections of the society across the country. The demands for extending reservations, on one pretext or the other, are on the rise from every nook and corner of the nation. This is resulting in politicization of the issue of Reservation.

In the given circumstances Constitutional framework alone sets the contours. Any other intervention in the issue can only aggravate the issue and open Pandora's Box.

It is to be understood that the reservation in promotion curtails the right of an Employee 100% in absolute terms. Since promotion of an individual, who is otherwise fully qualified, is denied to him/her only on the ground of caste; because Reservation anywhere else, allow the principle of 'survival of the fittest.' Anyone having talent, calibre and capability will be able to grab a place based on his meritorious performance, but it is not the case with reservation in promotions. It is for this reason, on behalf of working class the All India Equality Forum, also strongly opposes the proposed 117th Constitutional Amendment, with full force, which will otherwise practically nullify the judgment of the Constitutional Bench of the Honourable Supreme Court of India in the famous M Nagaraj and Others Vs. Union of India and others verdict delivered in October 2006.

All India Equality Forum is committed to stand for the cause of its members in particular and employees in general to seek justice on the issue of Reservations, fighting at all levels within constitutional framework.

It is very appreciable that the Electricity OC Employees Welfare Association A.P. is bringing out a Souvenir, on the occasion of Completion of Ten years of its formation, a true memorial of the event, and a media for dissipation of knowledge on the issues of reservation.

The subject of Reservation has become more live today, than ever before. Relying upon the Constitutional limits alone could control the Reservation issue, which is otherwise becoming more complicated.

It is admitted that at the time of Independence, India had a unique social background, with distinct disparity across different sections of society. That needed, what is called 'Affirmative action' or 'preferential treatment' for upliftment of the down trodden. Suitable policies, schemes, and legislations made from time to time have already served the purpose and today, after six decades, the things have changed. The very Scheme of Reservation needs a re-look, as today it is leading to 'Reverse discrimination'

The unhealthy impact of reservation in promotion with consequential seniority is evident in every department. The concentration of certain class at the upper hierarchies of the Departments is known to all. Juniors, enjoying reservation, are occupying higher posts earlier than the seniors, and are blocking promotional avenues of the unreserved category employees, who are compelled to work under the juniors and have to retire at lower levels, than they otherwise deserved. This situation is causing a heartburn and has become a national issue, requiring united efforts.

I am sure that we shall win the judicial battle with united efforts, for a better Nation.

I wish the Association a bright future with more achievements and service to its members.
